The brief terms & conditions of the Rate contract are given below :-

1. The material is to be supplied on F.O.R. basis at NIASM, Malegaon, Baramati.
2. S.T./Trade Tax and other Govt. levies will be paid extra as applicable.
3. The name of only one authorized dealer for the supply of above items be mentioned in the Rate Contract offer.
4. The quotations of the firms which have either been blacklisted or stopped dealing with the NIASM or any other ICAR Institute will not be accepted.
5. The firm should submit three copy of latest printed price list and soft copy of price list without which the Rate Contract will not be awarded. If the rate contract is to be done on old price list of the year 2014-15, the same will remain valid for the year 2015-16 and the same be clearly indicated on the document.
6. The firm has to submit the Registration Fee of **Rs.1000/-(Non-Refundable)** in shape of only **Demand Draft drawn in favour of ICAR Unit NIASM, Baramati payable at Baramati**. The Rate Contract Proposal will not be considered without registration fee.
7. The firm should submit the list of Govt. Organization/Institution with which they have rate contract of above items.
8. The rate contract will be valid upto 30.06.2016 or till the next rate contract will be finalized.
9. In case of sequencing services the rate should be according to product size.
10. Last date for submission of proposal is 04/06/2015.
