The Tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

1. ##### **1. Validity of Tender:**

2. All the tenderers should give an undertaking that they would render after sales service of the equipment/machine and will supply all spares/consumable for at least 5 years from the date of installation of the same.
3. The firm qualifying technical specification may be asked to demonstrate the performance/working of the quoted model of the equipment/machinery, if needed.

##### **5. PRICE:**

1	A Microwave Digestion system, completely microprocessor controlled to use in laboratory for digestion (Animal tissue sample, Soil, organic, inorganic, plant, sediment and rock samples), dissolution, extraction and drying of environmental samples.
2	The system comprising of a microwave power system, microwave cavity with exhaust fan, built-in microprocessor and rotating turn table with fool proof safety system.
3	Magnetron and Microwave output power: The system should have dual magnetron system with good diffuser for homogeneous microwave power distribution in the cavity and with microwave power output of 1500 Watt or higher. Power output should be selectable pulsed/un-pulsed. Magnetron frequency: $2450 \pm 10$ MHz. Protected by solid state Isolater for monitoring for fail safe. Instrument shut down in case of failure/ malfunctions.
4	Cavity Material: Large, illuminated stainless steel cavity should be coated with multilayer fluoropolymer (PTFE) or any better material, for easy cleaning and acid resistance, corrosion resistance.
