



INSTRUCTION TO THE TENDERERS

The Tender shall be submitted in accordance with these instructions and any tender not confirming the instructions as under is liable to be rejected. These instructions shall form the part of the tender and contract.

- For Online Bid Submission, as per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app). The bidders are required to submit soft copies of their bids electronically on the CPP Portal using valid Digital Signature Certificates. More information useful for submitting online bids on the CPP Portal may be obtained at www.eprocure.gov.in/eprocure/app.
- 2. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (<u>URL:http://eprocure.gov.in/eprocure/app</u>) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 3. The manufacturers/authorized distributors/dealers shall upload a self-declaration on their letterhead as PDF file in Cover-I of e-tender, along with the tender documents, confirming that they are regular in manufacturing/supplying of the item.
- 4. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.

- 5. The Technical Bids will be opened on 28.04.2021 at 03:00 P.M. The date & time for opening of Financial Bids will be notified on the portal. The bidders may regularly check the portal regarding the date of opening of financial bid.
- 6. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any Tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
- 7. The Director, ICAR-NIASM, reserves the right to reject any tender/bid wholly or partly without assigning any reason.
- 8. All the tender documents & Price Bid to be uploaded as per this tender are to be digitally signed by the bidder.
- 9. Bid Security Declaration: In place of a Bid Security/EMD, all bidders have to sign a "Bid Securing Declaration" accepting that if they withdraw or modify their bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids/request for proposals document, they will be suspended for the period of 5 years from being eligible to submit Bids/ Proposals for contracts with the ICAR-NIASM. - 10. The Tender Documents are not TRANSFERABLE under any circumstances.
- 11. Only Courts in Pune shall have the jurisdiction over any dispute arising out of this Tender.
- 12. The payment shall be arranged by this Institute within reasonable period of time on production of proper Printed Invoice/Bills (3 SETS) along with ORIGINAL, DUPLICATE AND TRIPLICATE SHEET with full details with advance stamped receipt.
- 13. The last date of tender is 27.04.2021 up to 1.00 PM. The Online tender shall be opened on 28.04.2021 at 3.00 PM. The incomplete tender will not be considered in any case and will be rejected.
- 14. In case, holiday is declared by the Government on the day of opening of online bids the received proposal will be open on the next working day at the same time.

GENERAL TERMS AND CONDITIONS OF PURCHASE ENQUIRY:

1. Validity of Tender:

a) The tender shall be valid for a period of 180 days from the date of opening of the tender.

b) No representation for the enhancement of the prices of the accepted tender or alteration of the terms and conditions will be entertained till supplies are completed.

2. The firm qualifying technical specification may be asked to mention site address of FYM for verification of item.

3. The tenderers should quote their rates on FOR basis. Rates should be quoted in Indian Rupees.

4. **PRICE:**

- i. Price schedule must be properly filled in and includes all other relevant charges.
- As per notification of Government of India, Ministry of Finance (Department of Revenue), Notification no. 45/2017-Central Tax (Rate) dated 14th November, 2017, this institute seeks exemption due to which GST payable will be 5% only (CGST @2.5% and SGST @2.5%)

5. Qualification Criteria:

Successful submission of all the details mentioned in Annexure-II along with relevant documents.

6. Terms of Delivery and Destination:

- i. The successful tenderer shall complete supplies strictly within the accepted delivery period. Material ordered by the ICAR-NIASM, Baramati shall be delivered FOR destination securely packed as may be necessary.
- 7. The tenders received late will be rejected.
- 8. The Director, ICAR-NIASM, Baramati reserves right to accept/reject any or all the tenders without assigning any reasons.
- 9. Any tender not accompanied by Earnest Money will be straight way rejected.

10. Performance Security:

- i. Within thirty (30) days, the successful tenderer shall furnish to the purchaser the Security Deposit equivalent to 3% of the purchase value.
